NON-PROFIT ORGANIZATION INFORMATION



- ⇒ Non-Profit organizations work at select concession locations during events.
- ⇒ In return for working the events at the Allen County War Memorial Coliseum, the Non-Profit Organization will receive a commission based on net sales.
- ⇒ All NPO group members **must** complete certain training classes in order to work. Additional training will be provided as needed.
- ⇒ ARAMARK management will ensure each group has completed all required training and will assist groups in the management of their stands.

COMMISSIONS

Commissions are based on a percentage of the total gross receipts from the stand sales, less applicable sales tax.

Number of Events	Commission Rate	Bonus
1-14	11.0%	N/A
15-22	13.5%	\$ 25.00
23-30	14.0%	\$ 50.00

Minimum Operations Requirements: NPO are required to commit to a minimum of 14 events between October 1st and September 30th

Age Requirement:

All Non-Profit group volunteers must be at least 18 years of age. Cashiers must be 21 to server beer.

Insurance:

Insurance is a mandatory requirement. The coverage will include ARAMARK at the Allen County War Memorial Coliseum .

Training:

All group leaders and volunteers acting as stand leaders must attend NPO orientation. This training will include basic food handling, customer service and stand operations.

For the volunteers, training will be hands on training.

Information will be provided regarding proper food safety handling, cooking guidelines, customer service and how to properly use the equipment and cash registers.

A trainer will be provided to your group for the first three events.

Uniforms

All volunteers will be attired in a collared golf shirt, black pants (no jeans), comfortable closed toe, closed heel, rubber-soled shoes, and a hat or visor.

Number of volunteers needed:

The number of volunteers needed to run a location depends upon the stand size and event. For a permanent stand, 8-10 volunteers. For a portable stand, 2-4 volunteers are needed. We recommend that your group has a strong volunteer pool of at least 15 volunteers to operate a successful season.
